When you complete your Workforce Registry account, some of the information, but not all with is shared with your employer when you select the “Present Job” button under “Employment History”.

The information which is shared with your employer is the data which is required for a program to apply across the program quality continuum. This includes the following:

- For matching purposes your name, Workforce Registry ID number, and date of birth
 - Highest level of education
- Higher education institution of attendance, major, diploma, and transcripts
 - Higher education start date, enrollment status, and graduation date
 - RI teaching certificate
 - First Aid/CPR dates and certificate
- Approved professional development hours and certificates

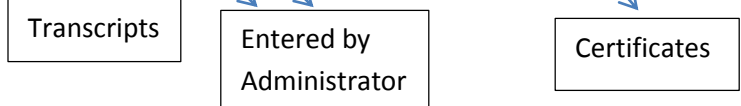
